IN ITS LIFETIME, THIS SERIES HAS SHOWCASED CHINESE ACROBATICS, AFRICAN GOSPEL CHOIRS, JAPANESE TAIKO DRUMMING, MEXICAN FOLKLORE BALLETS, UKRAINIAN DANCE COMPANIES, GIGANTIC PUPPETS, THEATRICAL CLOWNS, AND EVERYTHING IN-BETWEEN. IT IS IMPORTANT TO THE MISSION OF LEHMAN CENTER THAT EVENTS LIKE THESE ARE OFFERED AT A REASONABLE COST. IN 2024-2025 THE INTERNATIONAL SERIES INCLUDED: ENCANTO IN CONCERT, RHYTHM INDIA, WESTCHESTER BALLET COMPANY NUTCRACKER, AND THE PEKING ACROBATS.

THE CELEBRITY SERIES IS FOCUSED PRIMARILY ON SUPPORTING BLACK ARTISTS AND CATERING TO THE BLACK COMMUNITY IN THE BRONX BY BOOKING WELL KNOWN BLACK PERFORMERS THAT ARE RESPECTED AND REVERED. SOME NOTABLE PERFORMERS IN THE 40+ YEARS OF THIS SERIES INCLUDE STEPHANIE MILLS, HOWARD HEWETT, RUBEN STUDDARD, MARVIN SAPP, DIONNE WARWICK, GLADYS KNIGHT, SMOKEY ROBINSON, RAY CHARLES, B.B. KING, NATALIE COLE, AND CHAKA KHAN. IT IS IMPORTANT THAT THE CENTER CONTINUES THIS TREND OF PRESENTING BLACK ARTISTIC EXCELLENCE IN THE SEASONS TO COME. IN 2024-2025 THE CELEBRITY SERIES INCLUDED: DRUMLINE, FOREVER FREESTYLE 17, MCDONALD'S GOSPELFEST 2025, AND GOLDEN OLDIES DOO WOP.

LEHMAN CENTER ACCOMPLISHES ITS GOALS WITH SIX FULL TIME STAFF MEMBERS: EXECUTIVE DIRECTOR, ASSISTANT TO THE EXECUTIVE DIRECTOR, GENERAL MANAGER, BOX OFFICE MANAGER, TECHNICAL DIRECTOR AND MARKETING DIRECTOR. PART-TIME STAFF IS HIRED TO MANAGE EACH EVENT SUCH AS, SECURITY, MAINTENANCE, USHERS, STAGE HANDS AND HOUSE MANAGER.

ADDITIONALLY, THE CENTER OFFERED \$10 TICKETS FOR CHILDREN AND DISCOUNTS FOR SENIORS, STUDENTS, BRONX CULTURE CARD HOLDERS, AND MEMBERS OF THE THEATER DEVELOPMENT FUND. AS THE ONLY PERFORMING ARTS CENTER OF ITS SIZE (2,265 SEATS) IN THE BRONX PRESENTING INTERNATIONAL ATTRACTIONS, LEHMAN CENTER HAS ALWAYS BEEN A CULTURAL OASIS FOR UNDERREPRESENTED COMMUNITIES. SINCE 2019 THE CENTER HAS DEVELOPED EXTENSIVE MEDIA PARTNERSHIPS TO ANNOUNCE THE COMPLETION OF A \$15.4 MILLION RENOVATION TO BECOME TECHNOLOGICALLY ADVANCED AND FULLY COMPLIANT WITH ADA STANDARDS.
